

SCM: Crackdown on Media Workers in Syria



In mid-March 2011, the media scene in Syria has been witnessing what can be called a 'formal declaration of war on the media.' The Syrian authorities continuously attempt to crush the fourth estate that holds an influential power in society. This declaration of war started with a statement made by Buthaina Sha'ban, the political and media advisor to the Syrian president, when she stated the following in a press conference on 24/03/2011:

"Since the events are currently taking place in Syria, then only the Syrian state TV can report the truth, and no one else."

This statement came into effect when the media was prevented from entering Syria and work freely on its territory, except Syrian media outlets that hold close relations with the Syrian government, even these, were only allowed to cover specific areas.

The *Syrian Center for Media and Freedom of Expression* has monitored different forms of violations between February and October 2011. Below are the results of our findings:

114 Cases of Violations

114 cases were documented in which various forms of human rights violations were committed against 99 journalists, bloggers and intellectuals, who were harassed over their coverage of current events in Syria. 81 of these cases took place in the Syrian capital Damascus.

These violations took many forms, hence they are difficult to categorize, but the most notable ones are 32 cases of arbitrary detention and 76 cases of enforced disappearance, along with 6 cases where journalists were subjected to other forms of harassment. For example, Eyad Khalil, who was assaulted and humiliated in front of the security service as he explained in a statement. Also, Homam Haddad, who was working at Baladna newspaper and was forced to submit his resignation along with many other journalists who were forced to resign from their positions at Al Watan newspaper.

Samira Al-Masalmah's case is perhaps the most notable case among those subjected to forms of human rights violations in Syria. On 8/4/2011, Masalma was sacked after she had spoken to Al-Jazeera on the events in her city, Daraa. Note that Masalmah is the first woman to hold editor in

chief position at a newspaper in Syria: on 18/12/2008, the former minister of information, Mohsen Bilal, issued a decree appointing her as chief editor of Tishreen newspaper.

12 Cases of Repeated Detentions of a Journalist

9 journalists have been detained more than once, one of them is Amer Matar, who was tortured in his first detention. Three other detainees were detained three times over the past 8 months.

13 Female Journalists and Bloggers

Thirteen female journalists and bloggers were detained over their coverage of the Syrian uprising, five of whom were referred to court and charged mainly for "unauthorized demonstrations" and "rioting" based on articles No. 335-336 of the Syrian Penal Code. Lina Ibrahim's whereabouts and fate, on the other hand, remain unknown.

15 Bloggers and Bloggeresses


Fifteen bloggers and bloggeresses were detained over their coverage of the Syrian revolution. Four of whom were referred to court while the fate of Hussein Ghrer and Jihad Jamal remains unknown.

7 Photographers

Seven photographers were detained for taking pictures/footage of the Syrian uprising. Three of whom were referred to court, including Muzaffar Suleiman; head of photography division at Al-Watan newspaper, while Tariq Saed Balsha's fate remains unknown.

6 Intellectuals/Activists

SCM was able to document six cases where intellectuals and human rights activists were detained for contacting Arab and international media outlets, on which stating their views and experiences of the current events. A prominent case is the Syrian writer and human rights activist Mohammed Najati Tayyara who was detained at a checkpoint in Homs on 12/5/2011, he is still in detention.



31 Cases of Arbitrary Detention

31 journalists, bloggers and intellectuals were arbitrary detained then were referred to court. 29 of whom have been released while seven of them are currently on trial. The Court of Military Commissions in Aleppo has sentenced the journalist Alwan Zuaiter to five years in prison, lowered later to thirteen months, for charges of "insurrection in Syria". He is currently detained at the central province of Raqqa prison.

14 Cases of Unknown Fate


Fourteen Journalists and Bloggers are missing and no information about them has come to light since their detention; Six of them have been missing for over 60 days.

12 International Journalists

*- Of all international media reporters who were subjected to forms of human rights violations by the Syrian government, Reuters reporters' case was perhaps the most notable one. On 25/03/2011, the Syrian government revoked the press credentials of Khaled Yacoub Oweis, Jordanian, and the head of Reuters bureau in Damascus, over "false and unprofessional coverage" of events in Syria. Reuters later explained that "a senior official at the Ministry of Information notified Oweis that his press credentials has been revoked and that he is expelled from the country over false coverage, as the Syrian official stated, asking him to leave the country immediately." In addition, four people who worked with the "Reuters" in Syria were detained: Ayat Basmah, a TV producer, and the cameraman Ezzat Baltaji, both Lebanese. Also the Syrian photographer Khaled Al-Hariri and the Jordanian Suleiman Al-Khalidi, the agency's correspondent.

Violations committed against international journalists in Syria have attracted wide attention, especially, the case of Khaled Sayyed Muhannad, who was working for Radio France Culture and who was detained between 9/4/2011 and 3/5/2011. Upon his return to France, he spoke on intimidation as a form of psychological torture, which reached the threat to cut his sexual organ off.

Also the case of Al-Jazeera English reporter, Dorothy Parfaz, which attracted observers' attention when she disappeared upon her arrival at Damascus international airport on 29/04/2011. After numerous calls to locate her whereabouts, the Syrian authorities denied its knowledge of the whereabouts of the American-Iranian-Canadian journalist. Rumors were spread at the time saying that the Syrian authorities handed her over to the Iranian government. Dorothy appeared later on 18/05/2011 on a return flight from Tehran. SCM notes that the total number of foreign correspondents who have been harassed on Syrian territories has reached 12 cases, all of which were resolved upon leaving the Syrian territory.



*- Moreover, many Arab satellite news channels were severely attacked by pro-Syrian regime groups over their coverage of current events in Syria, Al-Jazeera in particular, whose bureau in Damascus was forced to suspend its work on 29/4/2011. It is worth to mention here that the head of Al-Jazeera bureau in Damascus, Abdul Hamid Tawfiq, had announced his resignation over "pressures" as he stated. He had been summoned more than once by different security agencies and by the Ministry of Information.

Furthermore, Syrian cell phone companies, MTN and SyriaTel, both halted Al- Jazeera's "Headline Text-Messaging" service on April. As for the incitement campaigns against the mentioned news channel, the most prominent case was the anchor Rula Ibrahim, whose family was forced to disown her after the intense pressure they were subjected to, which reached a threat to set their house on fire, as the anchor explained on 05/29/2011. Recently, these threats reached many of Al-Jazeera's crew along with their families. In response, the channel's administration condemned such threats in a statement issued on 10/7/2011 and declared the willing to file a lawsuit against those behind these threats.

*- It should also be noted, that the Syrian State TV along with media outlets that hold close relations with authorities, have launched incitement campaigns against activists on the one hand, and other media outlets, on the other, especially those who have approached the current events in Syria differently from the Syrian state's. The Syrian State TV's approach to current events has been "proving what other media confirms happening in Syria as lies," specifically channels like Al-Jazeera and Al-Arabiyya who are not allowed to enter Syria and cover the events. Furthermore, there were attempts to attack these channels' sources and accuse them of "treason," like eye witnesses, activists who take footage of the current events and others. Such attacks were either in the form of statement accusing human rights activists with treason on SANA. Syrian State TV and Syrian channel known to be close to the regime, Dunia, have been hosting guests calling for violently attack activists and media workers, who do not speak Syrian regime's story on current events.

The Syrian Center for Media and Freedom of Expression has received numerous complaints from journalists who have been subjected to defamatory campaigns launched by Al-Dunia TV, over their coverage of the events in Daraa. Such campaigns were accompanied by threat phone calls from fellow journalists working at State's owned media outlets or others that hold close relations to authorities.

- *- On the other hand, The Syrian Center for Media and Freedom of Expression monitored some cases in which Syrian media workers have been subjected to unknown individuals over working at Syrian State TV or at other media outlets close to authorities. Like, Sham Press director, Ali Jamalo, and Mustafa Al-Mikdad, editor director of Al-Thawra newspaper, whose both personal residences were set on fire. Syrian State TV's crew in Latakya, were harassed as well.
- *- Up to the issuance of this report, the policies of arbitrary detentions, intimidations and various forms of harassment on media workers are still being committed against journalists and bloggers in Syria. *The Syrian Center for Media and Freedom of Expression* is deeply concerned about such persistence of oppression, and condemns all forms of repression of freedom of speech against journalists, intellectuals and bloggers, and calls for the immediate disclosure of their fate, as well as for their release, from detention or prison. The Syrian authorities should open the door for media workers to perform their duties in Syria with guarantees for their safety, and must take immediate measures to ensure those rights.

SCM considers the detention of journalists a clear violation of Syrian constitution, specifically, article 38, which clearly guarantees citizens' right to state their opinions freely and openly, whether it takes the form of speech, written, or in any other form of expression.

Finally, SCM considers the above mentioned cases a violation to the international treaties and conventions, particularly the Universal Declaration of Human Rights, article 19. These violations also contradict Security Council's resolution 1738 (December 2006) which treats journalists as civilians and calls for their protection at times of armed conflict. This resolution is adopted by several international agreements and treaties that emphasize the need to protect journalists at times of armed conflict. The resolution referred to Geneva Convention of 12 August 1949, which constitutes the foundations to protect prisoners at times of war, precisely protocols 8 June 1977 article number 79, that stresses the need to protect journalists engaged in dangerous professional missions at times of armed conflict.
