


Total Casualties Since Mid-March 2011

Since mid-March 2011 up until **April 2023**, the Violations Documentation Center documented a total of **240,301** battle-related deaths.

● **145,808 (60.68%)** Among them were Civilians

• 94,493 (39.32%)
Were Non-Civilians








Deaths by the Parties Responsible


The parties responsible for the total number of deaths (civilian and non-civilian) from mid-March 2011 up until **April 2023**:

Battle-Related Deaths

During the month of **April 2023**, a total number of **86** deaths were documented across different Syrian governorates, among them, **86** were documented by full name and **0** was registered as unknown.






Deaths by Governorate

The largest number of documented deaths took place in **Daraa** with **34** deaths, followed by **Aleppo** with **19** deaths and **Homs** with **9** deaths for each.


24 deaths were documented in other governorates.

The number of civilian deaths reached 43 while the number of non-civilian deaths was 43








Causes of Death

57 deaths were caused by firearms and snipers, 4 deaths by aerial attacks and barrel bombs, and 9 battle-related deaths were caused by tanks, cannons and mortars.
0 deaths was caused by torture in Syrian government detention centers, 12 deaths were caused by land mines and car explosives and 0 death resulted from torture by kidnappers.
0 deaths were caused by lack of medical aid and relief in besieged areas and 0 case was caused by chlorine gas.

4 case of death was caused by other reasons.






Deaths by Gender

The total number of adult (over 18 years of age) male deaths is **77** while the total number of adult female deaths is **2**.

The total for child battle-related deaths is **7**, with **5** for male children and **2** for female children.
