
# **Total Casualties Since Mid-March 2011**

Since mid-March 2011 up until **January** 2025, the Violations Documentation Center documented a total of **243,387** battle-related deaths.

• **147,609 (60.65%)** Among them were Civilians

• 95,778 (39.35%) Were Non-Civilians








# **Deaths by the Parties Responsible**




# **Battle-Related Deaths**


During the month of **January 2025**, a total number of 290 deaths were documented across different Syrian governorates; all of them were documented by their full names.

# Deaths by Category: Civilian and Non-Civilian




The number of civilian deaths reached 239 while the number of non-civilian deaths was 51



#### **Causes of Death**

The number of people killed due to direct gunfire and sniping reached 117. Aerial bombardment caused the death of 47 individuals, while the number of those killed as a result of mortar shelling, artillery fire, and tank shelling amounted to 12.


Additionally, one person was tortured to death, and 75 people were killed due to war remnants and landmines. Finally, the center documented the deaths of 38 individuals due to other causes.



## Deaths by Gender

The total number of adult (over 18 years of age) male deaths is **247** while the total number of adult female deaths is **14**.

The total for child battle-related deaths is **29**, with **23** for male children and **6** for female children.







All figures and statistics presented in this report were retrieved from the database of the Violations Documentation Center (VDC). They are not final and are subject to continuous and periodic scrutiny by the VDC's database administrators and the field documentation team. Figures differ between reports and the most recent report is considered to be the most accurate.

We are very grateful to the members of the Field Documentation Team who risk their lives every day in order to document human rights violations committed in Syria and without whom the publications of the VDC would not have been possible.
