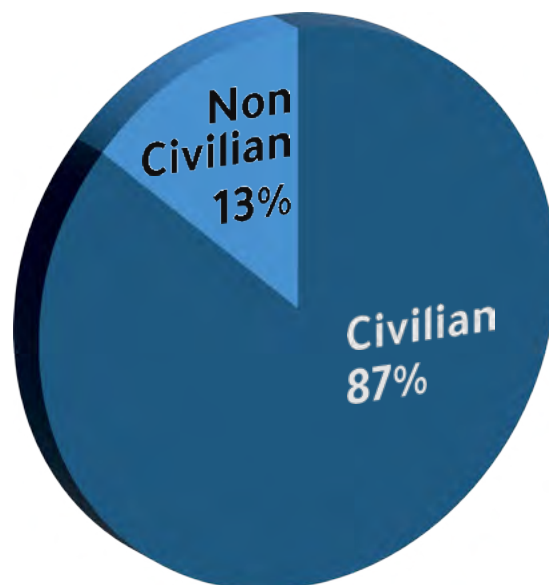
General Statistics



Number of victims since March 13, 2025

Between **March 13** and the end of **September 2025**, the Violations Documentation Project documented the deaths of **811** individuals in Syria.

- Civilians: **702 (87%)**
- military personnel¹: **109 (13%)**



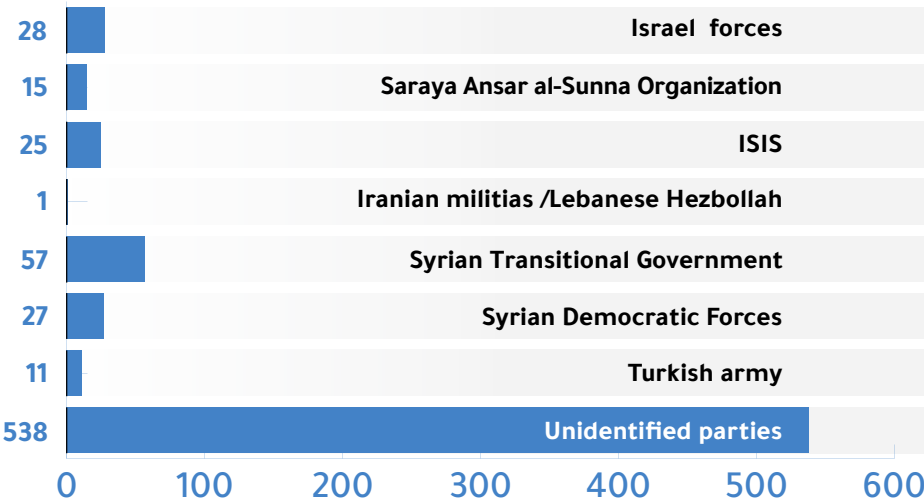

Parties Responsible for the Total Number of Civilian Deaths between **March 13** and the End of **September 2025**

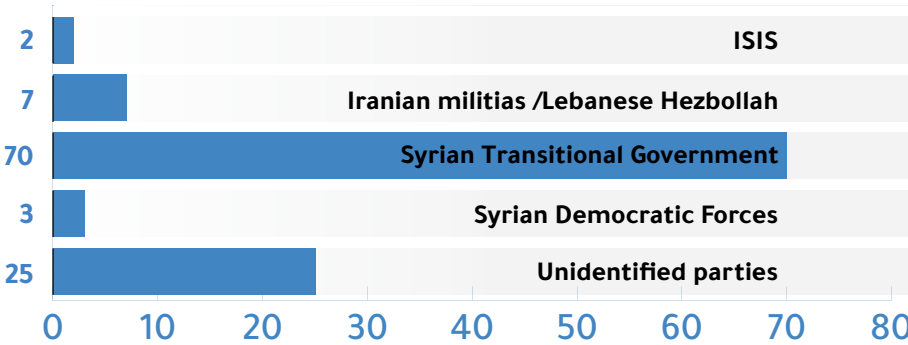

September 2025 Statistics

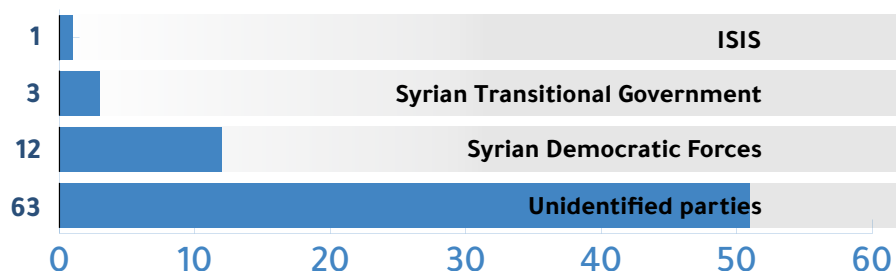
Number of Victims in September 2025

In **September 2025**, the Violations Documentation Project documented **67** deaths across various Syrian governorates. All individuals were fully identified by their full names.

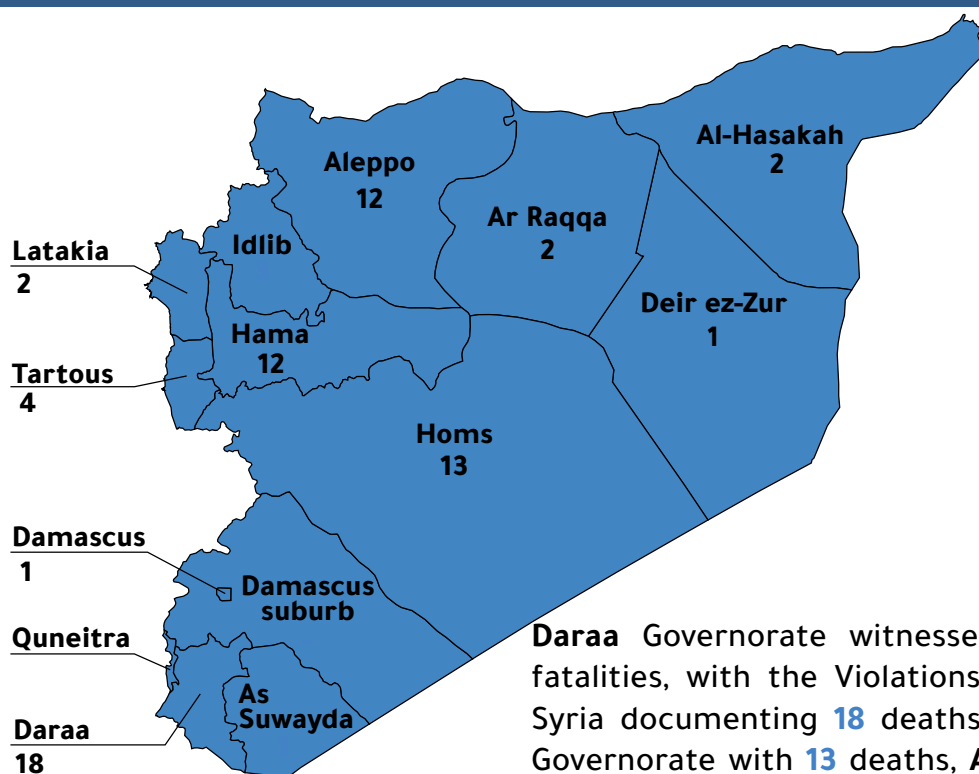
Civilian Deaths Attributed to Each Party

Deaths by Governorate



Daraa Governorate witnessed the highest number of fatalities, with the Violations Documentation Project in Syria documenting **18** deaths. It was followed by **Homs** Governorate with **13** deaths, **Aleppo** Governorate with **12**, and **Hama** Governorate with **12** recorded deaths.

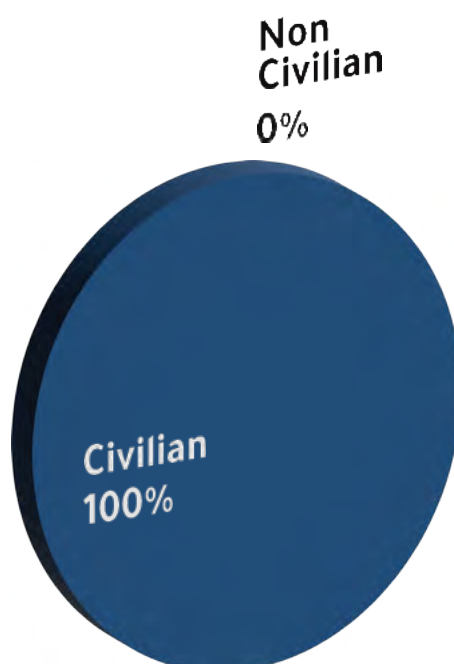
An additional **12** deaths were documented across the remaining Syrian governorates.

Deaths by Category: Civilian and Non-Civilian

The number of documented civilian deaths reached **67**, with no non-civilian¹ deaths recorded.

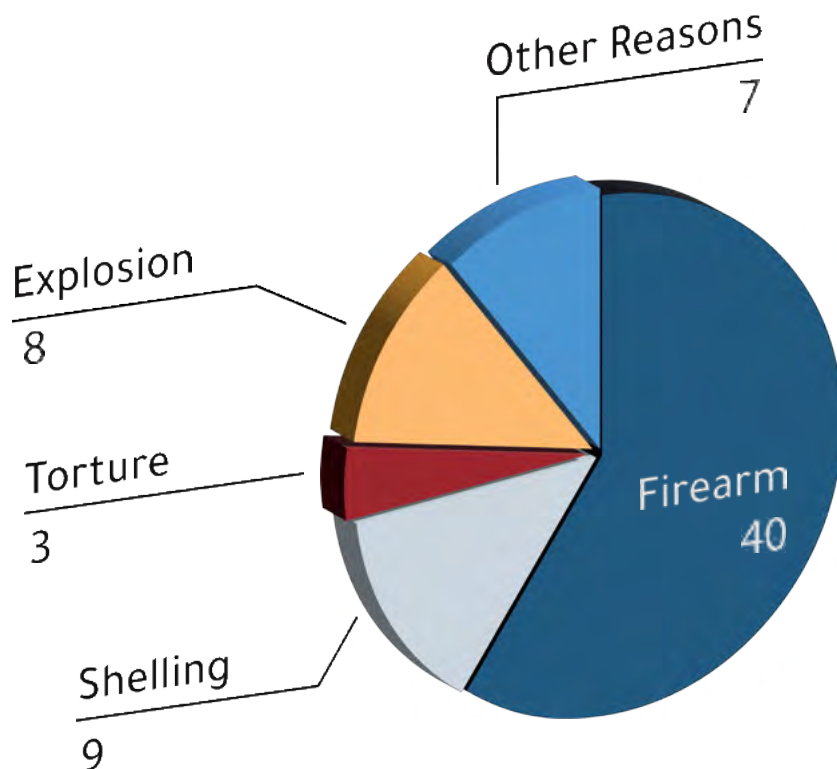

Distribution of Deaths by Cause

The number of deaths caused by direct gunfire and sniper fire reached **40**. Artillery shelling resulted in **9** fatalities. Deaths due to unexploded ordnance and landmines totaled **8**. Finally, the project documented **7** deaths attributed to other causes¹.



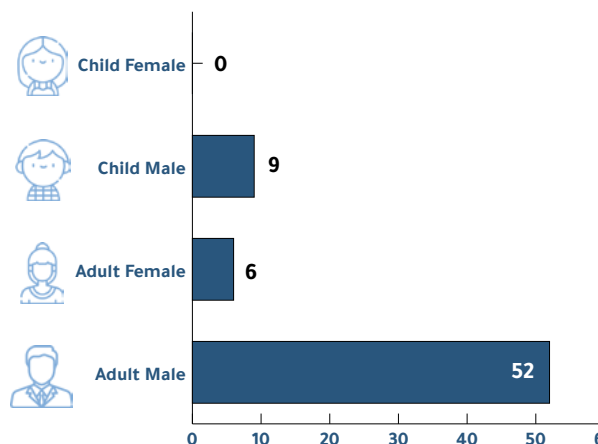

Deaths by Gender

The number of male adult deaths (aged over 18) reached **52**. The number of female adult deaths was **6**. Meanwhile, the number of male child deaths was **9**, and no female child deaths were recorded.

Number of Victims during the As-Suwayda Events

During the As-Suwayda events, the Violations Documentation Project documented **1,386** deaths in As-Suwayda Governorate.

- Civilians: **1116 (81%)**
- military personnel¹: **270 (19%)**

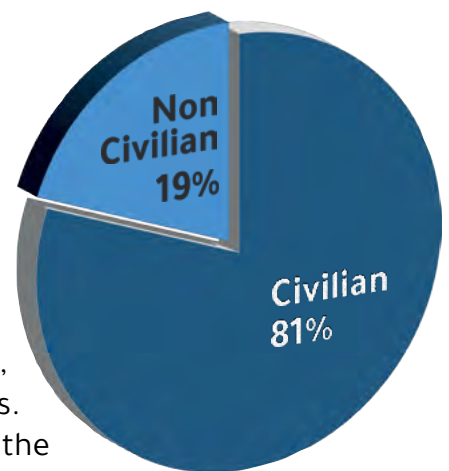

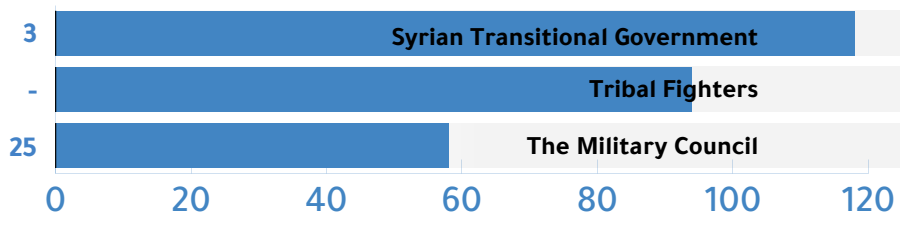
It should be noted that these data—both in terms of numbers and in terms of contexts and causes of death—remain preliminary and subject to verification. The purpose is to more accurately determine the number of victims, the surrounding circumstances, and to update information on the potential perpetrating parties. The documentation team also faces additional challenges due to the multiplicity of actors, limited access, and the large flow of information, part of which has been misleading or inaccurate. This complexity makes the verification process more difficult and requires additional time and effort.

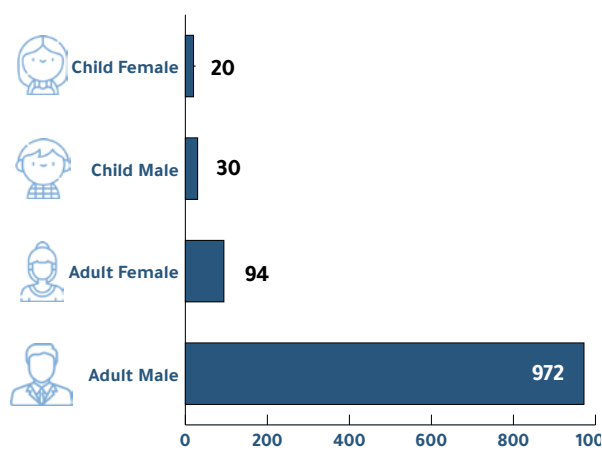
Number of Non-Civilian Deaths

Distribution of Civilian Deaths by Gender

The number of male adult deaths (aged over 18) reached **972**. The number of female adult deaths was **94**. Meanwhile, the number of male child deaths was **30**, and female child deaths totaled **20**.



The figures related to victims in As-Suwayda Governorate presented in this report are preliminary and still under verification. The purpose is to determine the contexts of the violations and to update information on the potential perpetrating parties, which makes these figures subject to change based on the outcomes of the verification process.

The Syrian Center for Media and Freedom of Expression (SCM) applies a rigorous methodology for documenting human rights violations grounded in international standards and best practices. This ensures that our documentation adheres to the fundamental principles of documentation, including impartiality, objectivity, accuracy, confidentiality, and do no harm.

Key aspects of SCM's documentation methodology include:

- **Information Collection:** Our team of documentation officers and field reporters gathers information through firsthand testimonies and open-source investigations.
- **Information Verification:** Each reported violation is corroborated by at least two independent and authentic sources that our team has thoroughly verified.
- **Cross-Verification Process:** All collected information, including testimonies, undergoes a comprehensive cross-checking process to ensure accuracy and reliability.
- **Victim Identification:** Only victims whom we can identify by name are recorded in the SCM data management system and included in our statistical reports. Unidentified victims are not included in these reports, but their information is securely stored until verification and completion are possible.
- **Standard of Proof:** SCM applies the “reasonable grounds to believe” standard, which requires that there be a reliable and credible basis for concluding that a violation has occurred based on corroborated information.
- **Monitoring and Updating the Database:** The database is continuously monitored for developments and changes, with new information and elements such as images and videos regularly added. In addition, periodic reviews are conducted to minimize potential errors that may occur during the data entry process.



All figures and statistics presented in this report were retrieved from the database of the Violations Documentation Center (VDC). They are not final and are subject to continuous and periodic scrutiny by the VDC's database administrators and the field documentation team. Figures differ between reports and the most recent report is considered to be the most accurate.

We are very grateful to the members of the Field Documentation Team who risk their lives every day in order to document human rights violations committed in Syria and without whom the publications of the VDC would not have been possible.
